

The undersigned Veterinary Official declares that:

- 1. The raw material (Milk) of the products described above originated from (Belgium, Netherland, Canada), which are foot-and-mouth disease (FMD) free countries that has been approved by DVS Malaysia.
- The milk products only contain approved preservative and food grade coloring matter.
- 3. The milk products shall not contain any residue or any foreign substance or harmful material injurious to health including melamine and that every precaution has been taken to prevent contamination during the processing, packing, storing and handling prior to export.

4. FMD virus inactivation treatment of raw milk to be used in the processing of milk products must be carried out by any of the following methods:

[ ] Ultra High Temperature (UHT) at minimum temperature of 132°C for at least 1 second; OR

[ ] the milk has a pH less than 7.0, High Temperature Short Time (HTST) at temperature 72 °C for at least 15 seconds; OR

[  $\sqrt{\ }$ ] the milk has a pH of 7.0 or greater, HTST applied twice.

5. Packages and containers such as carton boxes for raw milk and/or milk products to be exported to Malaysia must be clean and hygienic.

6. The milk product has been processed, packed and stored under sanitary condition in processing plant that has been approved by DVS Malaysia.
